

## **IAODAPCA CERTIFIED COUNSELORS APPLYING FOR THE MISA BOARD REGISTRATION GUIDELINES**

Alcohol and Other Drug Abuse (AODA) Counselors who hold a current certification with IAODAPCA can add the MISA Board Registration credential as a specialty area at a reduced cost and condensed completion of the application. The advantages to being an IAODAPCA certified counselor and receiving the MISA Board Registration are:

- MISA Biennial Fee \$20.00 Vs \$120.00 (MISA I) or \$140.00 (MISA II)
- Maintenance of MISA Board Registration 10 CEUs (MISA Specific) vs 40 CEUs
- Recognition as a professional working with the MISA Population

**IAODAPCA certified AODA counselors applying for MISA I/II Board Registration will need to complete the MISA Application with the following information:**

- 3. Supervised Practical Experience Form – Page 6**
