Training of Leaders – Navigating the Challenges of Cultural Change

This workshop is for current and future leaders in the field of addiction recovery. In a post-pandemic world, it is even more important to examine how culture impacts how well we work together. Examining workplace culture through the lens of equity, diversity and inclusion provides a framework that can enhance and inform recovery service delivery. Recognizing and understanding workplace culture and cultural humility allows for the removal of barriers to change in our organizations.

Workshop D

What to Do When Your Client Say They're Hearing Voices? An Integrated Treatment Approach for Co-Occurring Psychosis and Substance Use Disorders

Dominique Phua, LCSW, CADC

Nearly half of all people with severe mental illness (SMI) report substance use, however many clinicians feel unprepared to work with clients that experience co-occurring SMI and substance use disorders. This workshop will provide counselors and recovery specialists with entry level knowledge of psychosis spectrum disorders and practical skills to engage these individuals in treatment. It will give special attention on how to integrate treatment of SMI and SUD concurrently with emphasis on peer advocacy and engagement.

The Value of Kinship: Supporting New Roles as a Caregiver
Nancy J. Phillips, M.S.-Psy, CAADC, CFPP

“Parenting again,” whether in kin care or as a grandfamily, the need for this role continues to increase as substance use issues create the need for a non-parent family member to assume responsibility for caring for our children – babies through teens. The most recognized in this situation are grandparents who are stepping up to fill the role. Kin are placed in positions of grief, concern of the loved one, the child’s trauma, unexpected financial stress, legal issues and fear if the relationship is terminated. This workshop will explore issues and potential solutions for the grandparents/kin fulfilling the parenting role. A snapshot of family caregivers will be provided. A definition of who they are and what they do in this role will be shared. The participants will learn about the joint work of the RAISE Act Family Caregiving Advisory Council and the Advisory Council to Support Grandparents Raising Grandchildren. Information about support services, state and federal, for both emotional and financial will be shared. Ideas will be offered for taking care of caregivers, their own health and wellness, as well as creating a fun and rewarding environment.

Workshop F
Understanding Racial Trauma in the Treatment of Substance Use Disorders
Maryse Nazon, Psy.D., CADC, CODP I and Lisa Vinson, Ph.D., LCPC, CADC, CODP I, CCTP-Level I, CCTP-Level II, ACS

Trauma has been recognized as a key contributing factor in developing and maintaining substance use disorder (SUD). Trauma incidents are not experienced the same way by all individuals, especially along racial lines. Because of these differences, the impact of racial trauma (i.e., trauma caused by incidents of interpersonal or systemic racism) primarily needs to be included in the assessment and treatment of SUD for People of Color and Indigenous individuals (POCI). This workshop will help participants understand how such impact limits the effectiveness of treatment approaches with BIPOC (Black Indigenous and People of Color) individuals with SUD and what culturally and client-centered strategies can boost treatment outcomes for that population. Learn how to use the Biopsychosocial Model framework to assess and treat individuals experiencing racial trauma. Explore clinical supervision, supervision issues, and advocacy.

Workshop G

The Drama of Original Choice

Cheri DeMoss, MA, LCPC, CAADC, NCADCII, MAC, NCRS

Clients who struggle with addiction or have a parent who struggles with addiction, more often than not, live significantly dramatic lives. Whether the drama centers around friends, family, job, money, romantic relationship or entanglements with the law, it feels as if it comes out of nowhere. This workshop will focus on the concept of original choice, whether conscious or unconscious. An original choice, made by clients, that create a sequential snowball of dramatic consequences. This self-inflicted drama feels normal and at the same time miserable. Participants will learn how to help clients identify when they are making an original choice. Where the decision comes from, and what beliefs it supports. How to help clients recognize the drama patterns they create and what to do about them will also be discussed.

Workshops H

Ethical Considerations

This workshop will provide a capstone review of the Code of Ethics as it relates to legal issues, dual relationships, self-care, clinical supervision, fairness and other areas. Participants will review various scenarios and apply the rules and codes to their decisions in critical situations. Weighing those decisions via evaluation of utility, rights, justice, common good and virtuous, while balancing all of this with their own values and morals.

Building a “Beloved Community”
Benneth Lee, MA, CADC

This workshop will describe and demonstrate how the four elements and three levels of the “Beloved Community” will enable formerly incarcerated men and women to become a nonviolent person and build relationships that result in a beloved Brother and Sisterhood. Participants will understand what they need to be educated on, how to sustain themselves, console themselves and celebrate themselves. How to sustain relationships and community norms will also be discussed.

Workshop J

Women and Substance Use: Providing Gender-Responsive Practices in Treatment Settings
Victoria Wynecoop-Abrahamson, LSW and Jami Wilson

Women who are impacted by substance use concerns often experience unique barriers that can be overlooked within traditional treatment settings. These barriers can be especially complex for women impacted by poverty, women of color, LGBTQ women and people who are pregnant or parenting, highlighting the need for equity-based approaches in gender-responsive care. To center gender-responsive care in substance use treatment services, it is vital to foster relational environments. This workshop will focus on implementing these relational environments by addressing the holistic needs of women that include mental and physical health, family and healing from trauma. It will support SUD counselors and recovery specialists to collaborate and discuss what creating these healing spaces can look like and consider the unique circumstances that the women experience interpersonally and within their communities.
